# SALES CONDITIONS

## 1) Your visit

### **Please use 1 booking form per visiting date and per group.**

Payment of the entrance tickets happens (in cash or by card) at the cash desk of Mini-Europe on the day of the visit according to the real number of participants. Price supplements for guided visits or didactic programs are paid to the guide before the visit. Drinks during the picknick and meals are paid in the restaurant.

### **All bookings for the restaurant, guides and combined visits have to be requested by written reservation. The booking is only regarded as confirmed after written confirmation of Mini-Europe.**

- When booking please provide us with a number of participants that is as accurate as possible. If the number of participants changes with more than 5 participants, Mini-Europe has to be informed at least 7 working days before the day of the visit.
- Each visitor has to respect the park regulations during the visit. The behavior of the children remains under the responsibility of the accompanying adults, please do not leave the children in the park without supervision.
- All our rates and descriptions are subject to any modification. Group rates and conditions are only valid for groups of at least 20 paying participants (15 participants for schools and 10 participants for groups of persons with a disability).

## 2) Special conditions

### **Special conditions for groups of adults and seniors (65+):**

One free accompanying person per coach and one free catalogue per person:

### **Special conditions for schools, youth movements and groups of persons with a disability:**

One free accompanying person and one free catalogue for 15 paying participants (for 10 paying participants for groups of persons with a disability). Additional accompanying adults pay the same price as the participants.

## 3) Guided visits, didactic programs and combined visits

### **Guided visits and didactic programs:**

The booking of guided visits and didactic programs are only done by written request (at least 2 weeks before the day of the visit) and are subject to the availability of the guides. Guided visits and didactic programs take place in groups of maximum 25 persons per guide. The supplement for guides is €90 per guide (or €150 for Brussels city tours). In case of tardiness, the guide will wait for 1h00 and will guide the shortened visit. If the group still hasn't arrived after one hour, the amount for the guide(s) will be demanded. In case of cancellation on the day of the visit, the total amount for the guide(s) will also be demanded.

### **Combined visits:**

The booking of combined visits are only done by written request (at least 2 weeks before the day of the visit) and are subject to availability. The group rates for combined visits are available starting from 20 paying participants. The supplement for combined visits depend on the chosen program. Mini-Europe cannot be held responsible for any modifications of prices by other attractions. In the program "A day with the Brusseleirs", the meal and transport are not included.

**Bookings and cancellations of guides or combined visits are only valid after written confirmation of Mini-Europe.**

## 4) Lunch at Mini-Europe

### **In case of meals at the restaurant, Mini-Europe offers two possibilities:**

- The self-service: each participant of the group chooses one of the proposed dishes (à la carte).
- The group menus: the group chooses one of the different menus of our group brochure. These menus have to be booked at least 3 weeks in advance. Only one choice of menu can be made for the whole group. A deposit will be requested and has to be paid in the 8 days following the confirmation.

**In case of cancellation or if the number of participants decreases with more than 5 participants**, Mini-Europe has to be informed by mail at least 7 working days before the visit, or the number of ordered meals will be billed. For the smooth running of services, we ask you to respect the agreed hours as much as possible. In case of delays of more than 30 minutes, Mini-Europe should be informed immediately. Otherwise, Mini-Europe cannot be held responsible for any problems regarding the organization of the meal.

**Bookings and cancellations of meals are only valid after written confirmation of Mini-Europe.**

### **Mini-Europe and privacy**
